of only some of the young people (e.g. if your monitored within the survey but not the focus groups) you can use the “Number not disclosing / Not known” option to show this. You can also include numbers of people who choose not to provide you with this information in the “Number not disclosing / Not known” category.

In general, best practice when collecting this sort of data is to allow young people to self-define their identity, for example by asking “do you consider yourself to have a disability?”, rather than asking “are you registered as disabled with the state”, but you may follow your own practices when collecting this information. You can use the template participant monitoring form (see Appendix 2) as a tool to help you collect this information during face to face activities if you wish to do so.

Appendix 2 - Example participant monitoring form

Instructions for working groups

This form can be used to collect information on the backgrounds of people who you have contact with during face to face activities such as focus groups, action research or dialogue events. It is up to your working group to decide if you wish to use this tool and there is no obligation to do so.

To use the form, simply distribute it at an event and tell participants it is up to them if they complete it or not. It is important that the participants are able to give their answers anonymously. You should not add any other questions which may make the person identifiable, such as questions on names or contact details. When you collect the completed forms you should ensure the person collecting them does not read them as they are given in, and that all of the forms are mixed together so that individual people cannot be identified.
